Situated on the Havant coastline in Hampshire, this 320-house development incorporates a mitigation area for over-wintering Brent Geese.

With direct access through sand dunes to the beautiful beach, Harbour Place boasts extensive areas of public open space and the renowned and innovative Sustainable Urban Drainage Systems (SUDS).

These SUDS networks not only prevent flooding, they are also aesthetically pleasing and help to encourage biodiversity. Greenbelt were the first company in the UK to become fully qualified to own and manage SUDS systems when they were introduced across the country.

How we made this possible

In December 2020 Greenbelt were approached by Barratt to analyse the public open spaces features on this site as well as a nature reserve for over-wintering geese. We have worked closely for many years with Barratt's Southampton office

and already manage numerous sites across the UK for Barratt David Wilson Homes.

We put forward a proposal for the ownership and management of both the public open spaces and the nature reserve that were financed by a PENTAD arrangement for the former and a commuted sum payment for the latter - as stipulated in the planning approval.

We were successful in our bid and were appointed by Barratts in January of this year.

Construction is now under way and we have been on hand to offer our in-house professional advice on open space features through our experienced Delivery Team.

This recently awarded site joins a substantial pipeline of projects that contains approximately 250 developments across the UK, all at various stages of transfer and being handled expertly by our Delivery Team.


